Principles of the Law of Armed Conflict (LOAC)

- Military necessity: Allows actions that are necessary to defeat the enemy, must be an attack
 on a military objective
- Proportionality: Requires that actions are not excessive in relation to the military advantage gained
- Distinction: Requires that combatants distinguish between civilians and combatants, and only attack combatants
- Humanity: Prohibits actions that cause unnecessary suffering, injury, or destruction

What Is Procedural Justice?

(Definition from Yale Law School Justice Collaboratory)

- Procedural justice speaks to the idea of fair processes, and how people's perception of fairness
 is strongly impacted by the quality of their experiences and not only the end result of these
 experiences.
- Individuals' perceptions of procedurally just encounters are based on four central features of their interactions with legal authorities:
- i. Whether they were treated with **dignity and respect**;
- ii. Whether they were given **voice**;
- iii. Whether the decision-maker was neutral and transparent; and
- iv. Whether the decision-maker conveyed trustworthy motives.
- For decades, our research has demonstrated that procedural justice is critical for building trust and increasing the legitimacy of law enforcement authorities within communities. As such, it has paramount implications for both public safety and officer efficacy.

St Paul Results May 25,2020- March 1, 2022

DOMINANT MODELS OF POLICE RESPONSE

Police responses to public protests and unrest have varied over time and depend on the motivation for the protests. The strategies largely fall into the following general models used to maintain public peace:

A "show of force" model that deploys police forces in overwhelming numbers in the hopes of preventing violence at protests and demonstrations;

An **"escalated force" model** that matches the level of police aggression to that of protesters who elect to use violence;

A "negotiated management" model that emphasizes police-protester communication ahead of protest events in the interest of developing and negotiating the limits of peaceful protest and preventing violence on the side of both police and protesters;


A **"strategic incapacitation"** model that relies heavily on the identification and arrest of instigators of violence against the police, other persons, or property; and

A "command and control" model, in which departments organize and deploy personnel and resources according to deliberate and careful planning that anticipates how a protest is likely to evolve.

Why So Many Police Are Handling the Protests Wrong | The Marshall Project

"Researchers have spent 50 years studying the way crowds of protesters and crowds of police behave—and what happens when the two interact. One thing they will tell you is that when the police respond by escalating force—wearing riot gear from the start, or using tear gas on protesters—it doesn't work. In fact, disproportionate police force is one of the things that can make a peaceful protest not so peaceful. But if we know that (and have known that for decades), why are police still doing it?"

Why are Police and Protestors Caught in a Bad Cycle?

- Police are trained to respond, not to plan
- "There's this failed mindset of 'if we show force, immediately we will deter criminal activity or unruly activity'
- The disconnect between rank and file and executive leadership
- Even a single protest isn't really a single protest
- De-escalation, of course, does not guarantee that a protest will remain peaceful, and when protests take an unpredictable turn, it can be challenging for police to estimate the appropriate level of force.
- "The time to make friends isn't when you need them, you have to be in front of it."



In this anonymous submission, participants in the uprising in Minneapolis in response to the murder of George Floyd explore how a combination of different tactics compelled the police to abandon the Third Precinct.





Protest policing: When do tensions escalate between protesters and police? (police1.com)

- A large body of literature shows that protesters are more likely to endorse and use violence in response to repressive tactics by police and other state agents. This is particularly true when perceptions of unjust force against protesters become widespread. For example, research shows that protesters who directly observed officers using disproportionate force during Occupy Wall Street protests in New York and Washington, DC in 2012 were more likely to shift their attitudes in favor of violence and to engage in violence themselves. Police that used their authority in ways that protesters deemed were unjustified had the effect of alienating protesters and propelling otherwise moderate, peaceful demonstrators towards defiance. Indeed, an after-action assessment of the police response to the 2014 protests in Ferguson, Missouri concluded that the overwhelming use of force by police had the "unintended consequence of escalating rather than diminishing tensions."
- On the other hand, when individuals believe that authority figures are treating them fairly, they are
 more likely to refrain from violence. Acts such as vandalism do not receive substantial support from
 protesters when protesters perceive that police have treated them fairly, and protesters are more
 likely to stick to nonviolent acts of civil disobedience to demand change, such as staging mass
 demonstrations or occupying public or abandoned buildings.
- In short, different police tactics yield different responses from protesters: tactical mismatches are likely to influence escalation as well as who joins or desists from protest events.

"Although less-lethal weapons are designed as an alternative to lethal weapons, we found a substantial number of patients with serious injuries, including many injuries to the head, neck, and face. United Nations guidelines state that these weapons should only be aimed directly at the extremities and that hits to the head, neck, and face are potentially unlawful. Although the results represent only a single region in a worldwide protest, these findings reveal that under current practices, projectiles are not appropriate for crowd control."

SAINT PAUL, MN - Today, Saint Paul City Attorney Lyndsey Olson announced plans for the resolution of civil unrest cases related to the events following the death of George Floyd. The Saint Paul City Attorney's Office Community Justice Unit will review cases using principles of individualized justice, supporting and protecting First Amendment Rights while maintaining public safety through a distinction between those engaging in peaceful protest and those engaging in aggressive, harmful behavior.

"Supporting healing in our community following the death of George Floyd means making a distinction between those peacefully protesting, and those causin destruction in our community," said City Attorney
Olson, "Our plans for resolving these cases strikes this


